#### 1. Call to Order

##### 4.a. October 13, 2025, regular meeting.

This item was deferred from the October 13, 2025, meeting in order to allow the applicant the opportunity to address the potential disqualifying issue(s) within the application. Board Member Jennifer Brittain seconded the motion. Following further discussion, the
